# Memorandum of Understanding (MOU)

For Academic Cooperation

Between

**Smt. Panchfuladevi Patil College of Social Work, Khadki**

Sitabai Arts, Commerce and Science College, Akola, run by The Berar General Education Society, Akola, is one of the leading colleges in Vidarbha since 1935. The college is working to provide uninterrupted education to many students in rural areas. The college is always at the forefront of implementing educational as well as social activities.

Smt. Panchfuladevi Patil Social Work College, Khadki, run by The Gramin Vikas Shikshan Va Krida Prasarak Mandal, Khadki. As per the name of this college, it is a pioneer in implementing various social activities along with academic work. The college has implemented many Government and Semi-Government projects. The college is an important centre for creating social awareness among the students and it is the only social work college in the university which has become famous in the social field in a very short time.

This Memorandum of Understanding (MOU) is being signed between Sitabai Arts, Commerce & Science College, Akola and Smt. Panchfuladevi Patil Social Work College, Khadki as both the institutions have the same educational and social objectives. In particular, since the curriculum and educational objects of the Department of Sociology are the same in both the colleges, the MoU is being signed with a view to create mutual harmony between the students and teachers from an academic and social point of view and thereby create harmony between the two institutions.

## Terms of MOU -

1. This educational agreement (MOU) is being made between Sitabai College, Akola and Panchfuladevi Patil College, Khadki for five academic sessions from session 2019-20 to session 2023-24.
2. This MoU will take effect from the date it is signed by representatives of the two institutions.
3. The code MOU/SACAKOLA-PKSWCKHADKI is being given to both the institutions to facilitate correspondence and other administrative work in accordance with this agreement.





4. This Agreement shall apply equally to both the Institutions for the five academic sessions as outlined above. This agreement will then automatically expire. This Agreement may be extended at the discretion of both parties.
5. If there is any defect in this educational academic agreement, both the colleges will have the same leeway to cancel the agreement.
6. If any of the two institutions want to cancel the MOU before the expiration of this academic contract, they can do so. The college wishing to cancel the contract will have to notify the concerned college 3 months in advance.
7. No one college shall be liable for the loss of any kind of educational material or any other things in accordance with this Agreement.

### Objectives of the MOU -

1. Use the knowledge of expert faculties from both the colleges to impart knowledge to the students.
2. To increase the participation of students in Co-curriculum activities in both the institutions.
3. To collaborate with each other in the field of research of both the colleges.
4. To increase the participation of students in educational projects and trips implemented in both the colleges.
5. projects to be implemented by Government and Semi-Government institutions to be completed jointly by both the institutions.
6. In order to provide equal benefits to the students in both the colleges for Library and other educational materials.
7. To conduct seminars, workshops and research projects jointly by both the colleges.
8. To provide a new platform for students in both colleges.
9. For internal exchange of teachers and students of both the colleges for acquiring new knowledge.
10. To give scope for innovation to the students of both the colleges
11. This academic agreement will be used for the acquisition of practical knowledge along with theoretical knowledge for students.
12. To guide the students of both the colleges on self-employment, job opportunities and competitive examinations in various fields.

To fulfil the above objectives, both the institutions have entered into this Memorandum of Understanding (MoU) and both the colleges will be committed to abide by it.

repugnant to the subject or context shall include its successors – in – office administrators and assigns).  
(First Party and Second Party are hereinafter jointly referred to as Parties and individually as Party) as

WHEREAS:

- A) First Party is a Higher Educational Institution named:
- B) Gramin Vikas Shikshan & Krida Prasark Mandal's Khadki, Sanchalit **Smt. Panchfuladevi Patil College of Social Work, Khadki, Akola.** First Party & Second Party believe that collaboration and co-operation between Themselves will promote more effective use of each of their resources, and provide Each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation with in area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for Advancing their mutual interests.
- E) **Sanmati Engineering College Washim** – the Second Party is engaged in running Engineering Courses–Washim-Malegaon,Sawargaon Barde,Washim – the Second Party is promoted by promoter name Group Address and background of the Company.
- F) Give related information, its branches, and dimensional information about the Industry concerned with whom the MoU is Sworn.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS.

CLAUSE 1  
CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties Shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.





1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the Definitive Documents;) as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2  
SCOPE OF THE MoU**

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight in to the latest developments/ requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops/ Industrial Sites for the hands-on training of the learners enrolled with the First Party.
- 2.4 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of – **Science and Technology and Innovation** .
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lecture to the students of the First Party on the technology trends and in house requirements.
- 2.7 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training .
- 2.8 **Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/ jobs;
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.
- 2.10 There is no financial commitment on the part of the “Gramin Vikas Shikshan & Krida Prasark Mandal’s Khadki, Sanchalit **Smt. Panchfuladevi Patil College of Social Work, Khadki, Akola**”, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

**CLAUSE 3 INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

**CLAUSE 4 VALIDITY**

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Sanmati Engineering College Washim**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Sanmati Engineering College Washim**, the Second Party after termination of this Agreement by way of communication, correspondence etc; shall not be construed as an extension of this MOU.

4.2 Both Parties may terminate this MOU upon 30 calendar days’ notice in writing. In the event or Termination, both parties have to discharge their obligations.

KEM Hospital Research Centre (KEMHRC) Pune, a society instituted under the Societies Registration Act, 1960, having registration no. MAHARASHTRA/1973/85/PUNE (a public charitable trust registered under the F/2866, 1985) & having PAN AAATK1046L (hereinafter referred to as "KEMHRC" as the context permits) and having its Registered Office at Sardar Moodliar Road, Rasta Peth, Pune 411 011, Maharashtra

Smt. P D Patil Social Work College, Khadaki Akola (M.S.) is involved in areas of social work.

Whereas, the KEM Hospital Research Centre and KEM Hospital are leading institutions working with a commitment towards equitable health for all – in urban and rural areas in and around Pune and other neighbouring districts. Alongside the medical service component of the hospital the KEM Hospital Research Centre (KEMHRC) addresses clinical and social science research, training and vocational interventions aimed at improving the lives, livelihoods and lifestyles of the population - the main determinant





of the health of a society. The institutional capabilities of the Hospital and Research Centre (1972) over the years have advanced from research in the medical field on topics intimately related to population control, health, hygiene and maternal and child health to embrace a horizontal approach in health care delivery in not only reproductive health (RCH) but also Psychiatry, sociocultural research, sexology and prevention of sexual abuse, thus striving towards optimal health and well-being of the community.

KEMHRC is engaged in research addressing Reproductive and Child Health (RCH), adolescent health, HIV and AIDS, quality of health services, women's development and various clinical topics. This is a multiple disciplinary approach which leads to providing quality services at the KEM Hospital and inform policy makers regarding evidence-based interventions. Many exploratory and interventional studies are undertaken which were funded by ICMR, Ford Foundation, USAID, IMPACT Foundation UK, Population Council New York, Government of India etc. Each project has to be approved by the Ethics Committee, before work begins on the project. Over 200 scientists and technicians as well as a large number of field staff are involved in research. A number of scientists have gained international recognition and their research papers have been published in prestigious international and national journals.

The Sexual Health Clinic at KEM Hospital has been operational for more than two decades and has provided therapy and interventions to those in need. Since 2018, it has also taken up the challenging and novel task of treatment of persons with paedophilia under the Program for Primary Prevention of Sexual Violence (PPPSV), with the aim of preventing sexual violence against children. This novel scientific treatment approach has been culturally adapted from the German program, Project Dunkelfeld to suit the Indian sociocultural and legal contexts. Various awareness and training activities and conferences are being carried out to sensitise the community, health care professionals and social workers towards the issue of paedophilia.

Research in Internal Medicine, Paediatrics, Gynaecology, Diabetes, Cardiology, Psychiatry, Gastroenterology, ENT, Oncology, Pulmonology, and ICU form part of the multi-centric clinical trials in the Research Centre. Inter-sectoral co-ordination and co-operation of NGOs, Government and the local communities are addressed effectively in the Research Centre with positive outcomes.

Whereas, both parties, viz., Smt. P D Patil Social Work College, Khadaki Akola (M.S.) and KEMHRC, Pune realize that in the current context, working together is desirable to promote awareness about paedophilia and availability of treatment for the same in order to reduce CSA, using facilities and expertise at both the places. Therefore, both parties are agreeable to enter into a MoU for working and cooperating with one another and using their respective expertise, knowledge and resources.

#### **Article I: Principle of Cooperation**





Smt. P D Patil Social Work College, Khadaki Akola (M.S.) and KEMHRC, Pune agree to develop their mental health/community work/social work links especially in the fields of mutual interests under the principles of mutual understanding, common interest and mutually complementary activities.

1. To develop collaboration(s) between Smt. P D Patil Social Work College, Khadaki Akola (M.S.) and KEMHRC, Pune with regards to the project on Upscaling and Sustainability of **“Program for Primary Prevention of Sexual Violence” (PPPSV)** (**“Gen Project- CSA Bayer- Upscaling and Sustainability”**) with a focus on creating and Implementing Culturally Adapted Media Content highlighting cultural differences for self-identified, motivated, & non-offending persons with Pedophilia to come forward for assessment & treatment.
2. To promote awareness, encourage research and reduce stigma in the field of sexual paraphilias, specifically paedophilia and prevention of CSA
3. To help strengthen the networks of Don't Offend India and make collaborative efforts for sustainability of PPPSV program.
4. To promote association among experts and personnel of both the institutions.
5. To provide opportunities for the experts and eligible persons at both the institutes to conduct and attend relevant seminars, workshops, lectures and trainings for their experts and staff after completing the due formalities.
6. To promote exchange of thoughts by brain-storming sessions/seminars/workshops/conferences and meetings.
7. To encourage creation and distribution of awareness and orientation materials and joint research writing for books, manuals, policy briefs, peer-reviewed journal publications and allied print media.
8. To work jointly for the common interests at national and international levels, which may include conducting awareness and training sessions, collaborating with government functionaries, providing referrals, helping with recruitment, disseminating information, providing mentorship and Internships, preparation and submission of proposals for funding to national and international agencies and its implementation.



9. To support exchange of academic, research and training material.
10. To share experiences and expertise concerning administration and management in the field of CSA prevention and paedophilia.
11. To encourage any other relevant academic, research, awareness and training activities that both the institutions agree to be on mutual benefit such as organizing National/ International Conferences, conducting training programs for skill development etc.

## **Article II: Areas of Cooperation**

1. Scientists/Researchers/Staff working at KEMHRC, Pune may be enrolled for relevant programs, workshops, courses, certifications, trainings offered by Smt. P D Patil Social Work College, Khadaki Akola (M.S.) after following the due process prescribed by Smt. P D Patil Social Work College, Khadaki Akola (M.S.).
2. Collaborating in creation and dissemination of materials for creating awareness on Pedophilia in the community (where applicable) and through Social Media which includes existing channels and upcoming channels/platforms of social media by using various strategies/interventions.
3. Scientists/Researchers at KEMHRC, Pune may deliver lectures/seminars, conduct training workshops in areas of their specialization for the eligible personnel of Smt. P D Patil Social Work College, Khadaki Akola (M.S.) on days and timings pre-arranged on mutual consent.
4. KEMHRC, Pune may provide short term project/training to the personnel of Smt. P D Patil Social Work College, Khadaki Akola (M.S.) in their areas of specialization.
5. All publications arising out of the joint work, by the team of KEMHRC, Pune must mention the affiliation as 'Smt. P D Patil Social Work College, Khadaki Akola (M.S.)' in addition to their own institutional affiliation.
6. Data generated through such collaborative work will be published in scientific journals jointly with a copyright. However, the ownership of data would remain with the institution from where the data are collected, with other institution being the custodian of the data with equal rights to use the data responsibly. Even if one party

is owner and other is custodian of the data, both parties would use data with mutual consent.

### **Article III: Duration and Termination of the MoU**

1. This MoU shall become effective as on the date of signatures by the Authorities of Smt. P D Patil Social Work College, Khadaki Akola (M.S.) and KEMHRC, Pune.
2. This MoU is valid from the Date of execution by the Parties and shall remain in effect for two years, and thereafter may be renewed, based upon mutual agreement.
3. This MoU may be amended at any time by written mutual consent.
4. This MoU may be terminated by either party by giving written notice of their intention to terminate MoU not less than three/six months prior to the desired termination date. 
