

PSO 5 : This programme seeks to inculcate a humanism attitude in the students.



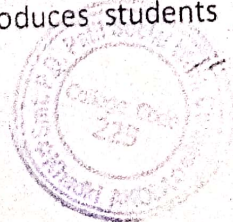


